| <b>Late Filing Fee: There is a penalty for failing to obtain a Building Permit prior to commencement of construction. Each permit constitutes a separate offense. Penalties as follows:</b>   |                            |
| First offense: \$300.00 + Permit Fee above  |                            |
| Second offense: \$600.00 + Permit Fee above   |                            |
| Third offense: \$1,200.00 + Permit Fee above  |                            |
| Permit fees for commercial and industrial projects costing \$1,00,000 or more may be reduced to more accurately reflect the cost to Town services. The fees for all Municipal and Governmental projects may be reduced or waived to more accurately reflect the cost to Town services and the cost to Taxpayers in general and/or the public benefit to be obtained from the Project. |                            |
